Frugal innovation encompass high-performing product or process technologies at an affordable price point. Frugal Innovations are characterised by high affordability, robustness and are designed for volume-driven market. It is a unique opportunity for participants to identify and share IP challenges encountered during the ideation, design, and production or implementation stage of the innovation undertaken to achieve frugality.

Objectives of the Confluence

The theme for the 4th IPR Researchers' Confluence is "IP Challenges in Frugal Innovation". The objective is to identify challenges posed by intellectual property across various stages in developing frugal innovations, and to explore possible solutions for such challenges.

The format for presentations for the Confluence is case-based, wherein presenters can share their experiences during product or process development for frugal innovations and the challenges encountered during this undertaking.
