Introduction

The Department of Social Justice, Empowerment and Culture is responsible for welfare of persons with disabilities in Lakshadweep. The union territory has an estimated population of 1678¹ persons with disabilities in a total population of 64,429² people. Lakshadweep implements two schemes under Skill Development & Employment, three schemes under Social Security, Health, Rehabilitation & Recreation and has notified authorities for disability Certification and certifying Organisations & Individuals for Persons with Disabilities.
