### Date: 05.03.2016, Saturday

  - a. Padmini: Presented research on Reconsideration Requests and raised a point as to its relevance
  - b. Vidushi: Presented statistics to show that ICANN's processes were not truly representative or multistakeholder, and suggested proactive outreach as a possible solution.

Padmini raised concerns about the lack of a sexual harassment policy at ICANN, which the Board committed towards the development of. Vidushi presented research on diversity within ICANN and repeatedly urged for process to be more proactively participatory. We were referred to the legal team for a more concrete explanation of steps.
