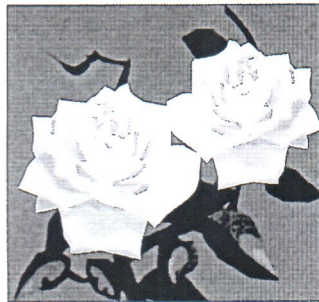

- i. **System of Accounting:** "Cash System" of Accounting is followed. Receipts and Payments are recognized as and when cash is received or paid.
 - ii. **Fund Accounting System:** Funds received are earmarked in nature with specified budget lines. Hence Fund Accounting technique is adopted. Balance of each fund are shown as liability under the title "Undisbursed Earmarked Funds" in the balance Sheet.
 - iii. **Depreciation:** No depreciation is considered on fixed assets as they are not employed for business and they have become donated assets on the trust.
 - iv. **Fixed Assets:** They are stated at cost (Historical Cost). No assets are revalued during the year.
 - v. **Inflation:** Current costs are not adjusted to reflect the cost of inflation.

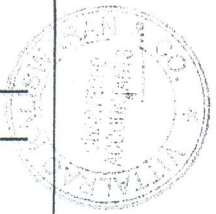

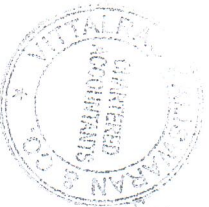

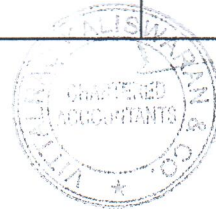
