- Please list the companies from which BSNL has bought all its security equipments.
- What type of security equipment does BSNL use to assist Indian law enforcement agencies in detecting and preventing crime, terrorism and all other illegal activity? Please provide the certification for all such equipment.
- What malware does BSNL test for? What does BSNL use for testing malware in its networks?
- Which proxy servers does BSNL use and are they used for filtering data? If so, what type of data is being filtered and for what purpose? Is authorisation required and if so, by whom?
- Does BSNL use FinFly ISP? If so, who authorises its use and under what conditions?
