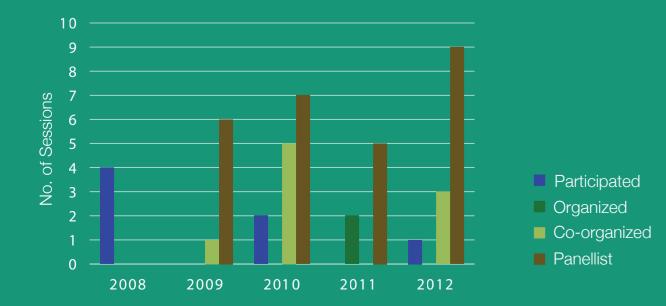
# INTERNET GOVERNANCE HORUM (IGF)

Internet Governance Forum brings "people together from various stakeholder groups as equals, in discussions on public policy issues relating to the Internet. While there is no negotiated outcome, the IGF informs and inspires those with policy-making power in both the public and private sectors. At their annual meeting delegates discuss, exchange information and share good practices with each other. The IGF facilitates a common understanding of how to maximize Internet opportunities and address risks and challenges that arise. The IGF is also a space that gives developing countries the same opportunity as wealthier nations to engage in the debate on Internet governance and to facilitate their participation in existing institutions and arrangements. Ultimately, the involvtement of all stakeholders, from developed as well as developing countries, is necessary for the future development of the Internet."

Internet is commonly known as the network of networks. There is no one body or institution which governs the internet. Given the increase in the use of internet in our daily lives and the growing significance of internet in the information society, there was a need to address the issues of governance. During the early stages of the internet, the major debate revolved around the question whether the net can be governed. However, in the recent years the focus has changed to a different question. Today we ask the question whether there can be anything different; in the way we try to govern the internet. In this context, Internet Governance Forum (IGF) acts as a forum for:

- (i) Policy-setting Stakeholders can collaboratively decide upon the objectives to be achieved, and
- (ii) Coordination The process of establishing how and by whom they are to be achieved.
