


# US slams Pak for N-arsenal boast

Washington: Pakistan's nuclear sabre rattling earned for it a mild reprimand from the Obama administration even as military generals in Rawalpindi told the country's politicians that India is their principal external threat and they need more money to counter it.

Border tension between India and Pakistan figured in the daily US state department briefing on Thursday with spokesman cautioning Islamabad for talking loosely about using nuclear weapons to counter India.

"We want to see tensions decrease, and speculation about potential use of nuclear weapons certainly isn't doing anything to help it, if in fact those comments were made," spokesman John Kirby said.

The censure came after Pakistan's geriatric NSA Sartaj Aziz boasted that Pakistan was a nuclear weapons power that was capable of defending itself against India, even though New Delhi has made no nuclear threats and has a no-first use policy when it comes to nuclear weapons use.

Kirby essayed the familiar salutary advice to a country that is home to a wide range of terrorists and terror groups, some of them designated by the UN and US.

"(US) secretary (of state, John) Kerry has said repeatedly that he wants the two nations to continue to work together, with constructive dia-

logue, to resolve their issues, and we understand that there are issues that are longstanding," Kirby told reporters. "But that's what really needs to happen, is sitting down, dialogue, cooperation, talking through these things, and trying to work through some meaningful solutions."

Earlier in the week, the state department had repeated the familiar mantra that such talks were something the two sides needed to undertake and no mediation can be expected from a third party.

Pakistan has been trying hard to attract international attention and mediation into the Kashmir dispute while not giving up on its patronage of terrorist groups such as LeT and its avatars and helping militants infiltrate into India. Earlier this week, Pakistan's ambassador to the UN Maleeha Lodhi took its complaints to the UN even though Pakistan protects UN designated terrorists such as Hafiz Saeed.

On Friday, Pakistani media reported that in a briefing at the joint staff headquarters, the generals told members of Pakistan's senate defense committee that India was buying \$100 billion worth of weapons over the next five years aimed primarily at Pakistan, and they needed more money to counter that.

# Modi to address mega reception at Wembley

London: Prime Minister Narendra Modi is expected to address a large reception at the Wembley Stadium, which has a capacity of 90,000, in London in November when he is due to visit the UK.

The invitation-only event is expected to be one of the largest receptions accorded to a foreign head of government and will be

themed "two great nations, one glorious future" to celebrate India-UK ties. Organizers Europe India Forum have planned for Modi to deliver the keynote address followed by an impressive fireworks display as his visit coincides with Diwali.

Modi will stop over in London for three days around November 12 on his way to Turkey to attend the G20 summit in Antalya scheduled for November 15-16. Among those invited to the reception are British Members of Parliament, eminent businessmen and people from the

field of arts, culture and entertainment. Organizers said the website [www.ukwelcomesmodi.org](http://www.ukwelcomesmodi.org) will go live on Saturday to allow organizations and individuals to register.

Wembley Stadium is one of London's most recognized features and the area has a high percentage of people of Indian origin. Organizers said the PM will be given an Olympic-style reception that will reflect his popularity with the British Indian community and boost India-UK ties.

## PM may attend RSS-BJP meeting next week

Prime Minister Narendra Modi is likely to attend a meeting of RSS and BJP leaders next week that is expected to take stock of the progress of the NDA government and deliberate on coordination issues including relations with Sangh organizations. The meeting, ahead of the Bihar election, is significant for its focus on coordination and communication between the Sangh and its affiliates. The Bihar election has acquired a certain salience as it is seen to be a major test of strength for Modi and BJP after the defeat in Delhi. The discussions will also aim to evolve closer understanding over contentious issues like labour reforms and land acquisition and economic liberalization on which Sangh affiliates have taken stands that differ with the government. The meeting of senior BJP functionaries with the Sangh brass is intended to ensure that both sides understand and appreciate one another's priorities and is part of regular exercises to achieve better outcomes. # Pak: India's no to secy meet nixed NSA talks

New Delhi: After India and Pakistan publicly sparred over Hurriyat and accused each other of tampering with the Ufa agenda, Islamabad has now alleged it was the failure to ensure a meeting between its foreign secretary Aizaz Chaudhry and his Indian counterpart S Jaishankar which put paid to hope of holding the NSA-level dialogue.

On August 21, India officially conveyed to Pakistan that a meeting between the foreign secretaries wasn't possible. Indian officials said it wasn't a part of the Ufa agenda. According to India, the meeting was suggested as an afterthought and after it had become evident that Pakistan wasn't interested, going by the delay on the part of Islamabad in confirming the dates.

Pakistan had proposed the meeting, on the sidelines of NSA dialogue, to discuss modalities for further discussions on what it describes as the core issue of Kashmir. This was apparently important for Sharif as he was keen to convey that the issue remained as significant as ever for Pakistan, after he allowed India to not mention J&K in the Ufa statement. The Ufa statement did not mention any meeting between the foreign secretaries.

Pakistan believes the talks were taking place after two back-to-back concessions by the Sharif-led civilian government to India.

The Pakistan foreign office on Friday summoned the Indian high commissioner, reports Omer Farooq Khan. This was followed by a warning from the defence minister against New Delhi initiating a "limited war", saying eight of its civilians were killed and 47 hurt in firing and shelling from across the border. The military's media wing said the injured included 24 women and 11 children.
