The PIO vide its letter no. JNU/RTI/CPIO/4489/2014/3116 dated 27th January, 2015 has forwarded an RTI application of Ms. Nehaa Chaudhari, Center for Internet and Society, G-15, Hauz Khas, New Delhi-110016 asking for certain information under RTI Act vide RTI application (ID no.4489), which was received through CPIO on 29.01.2015. The point wise information/reply to the queries made by Ms. Nehaa Chaudhari is proposed to be given as under:

Query No.1. Report on the implementation of the Intellectual Property Education, Research and Public Outreach (IPERPO) scheme and the MHRD IPR Chair funded under the scheme at Jawaharlal Nehru University for the year 2013-2014

Reply: An amount of Rs.10,00,000/- was sanctioned by the MHRD for the establishment of IPR Chair at the Centre for Economic Studies and Planning during March 2008 and the same is lying un-utilized since this amount is not adequate to meet out the expenditure relating for further activities to start the Cell. Accordingly, it has been requested to the MHRD for an additional amount to make the Chair functional but we have not received any response so far from the MHRD. Hence, no activity has been done under the IPR Chair due to above reason.


Madam,
