The undersigned is directed by order of the Governor to state that the Governor has been pleased to sanction a sum of **Rs. 52,800/- (Rupees fifty two thousand eight hundred)** only towards payment of remuneration to private/non-Govt. Clinical Psychologist at the rate of **Rs.400/(Rupees four Hundred)** only per sitting per space each such private Clinic Psychologist to be engaged at each of the 11 (eleven) District Medical Board for Mentally retarded people so constituted vide this **Deptt. Memorandum No. HF/O/PHP/63/6M-16/2001 dtd. 15/01/2004** for examination and certification of Mentally ill/retarded persons for each of the following eleven districts :-

at the rate of 2 (two) such sitting per month for the months of **October, 2004, November, 2004, December, 2004, January, 2005, February, 2005 and March, 2005** i.e the 6 (six) remaining months of the current Financial Year **2004-05**.

2. the Superintendents of each of the said 11 (eleven) District Hospitals of the said 11 (eleven) Districts will act as the Drawing and Disbursing Officer (DDO) for drawal and disbursal of the amount sanctioned herein above.

3. The Governor is also pleased to place a fund of Rs. 52,800/- at the disposal of Addl. Director of Health Services (AAV) who will, in turn, re-allot the same to the respective Superintendent of the above mentioned eleven Districts at the rate of Rs. 4800/- per district.

4. The charge is debitable to the head of account "2210-01-110-NP-010 Mental Hospitals etc. 28 - Payment of Professional and Special Services" to which fund required for the purpose is being provided by way of reappropriation from the saving under the detailed head "21-Materials and Supplies / Stores and Equipments" under the same major head of Account in the State Budget of the current financial year (2004-05).

5. Copies of detailed expenditure statement as well as utilization certificates incorporating the detailed particulars of the private/non-Govt. clinical psychologists deployed started have to be furnished to this Deptt. within 60 (Sixty) days from the date of drawal of the fund sanctioned herein.

6. In incurring the above expenditure, relevant Govt. order and existing tratesa should strictly be followed.

7. This order issue with the concurrence of the finance Deptt. vide their U.O. No. Group 'O' No.721 dtd. 26/08/2004 read with Group 'N' U.O. No. 1063 dtd. 11/08/2004.

8. The Principal Accountant General (A&E), West Bengal and other officers concerned are being informed.
